FW Bureaux; 14.01.31 - Grants-in-Aid-General, in Demand No.44- Health & Family Welfare during 2021-2022. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.

5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3017 Dated 09 Mar 2022.


