I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 3,47,45,000.00 (Rupees Three Crore Forty Seven Lakh Forty Five Thousand Only)** to the state of **MAHARASHTRA** towards liquidation of **Arrears for the F.Y. 2016-17 and 2017-18** for implementation of Infrastructure Maintenance - **Urban Family Welfare Centres (UFWCs)**, a Centrally Sponsored Plan Scheme during **2021-2022**. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
