

- I am directed to convey the sanction of the President to the payment of grants-in-aid of Rs.3,14,49,000.00 (Rupees Three Crore Fourteen Lakh Forty Nine Thousand Only) to the state of ODISHA towards liquidation of Arrears for the F.Y. 2019-2020 for implementation of Infrastructure Maintenance - Maintenance of State/Distt. FW Bureaux; 14.01.31 - Grants-in-Aid-General, in Demand No.44- Health & Family Welfare during 2021-2022. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
  4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
  5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-2906 Dated 28 Feb 2022.
