

I am directed to convey the sanction of the President to the payment of grants-in-aid of Rs. 33,90,000.00 (Rupees Thirty Three Lakh Ninety Thousand Only) to the state of ODISHA towards liquidation of Arrears for the F.Y. 2019-2020 for implementation of Infrastructure Maintenance - Health and Family Welfare Training Centres (HFWTCs), a Centrally Sponsored Plan Scheme during 2021-2022. With this release, the arrears will be partially settled for the F.Y. 2019-2020.

This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-2906 Dated 28 Feb 2022.
