3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The State shall ensure that 40%/10% (as applicable) of its share based on release of funds by GOI is credited to appropriate accounts.

5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

6. Grants-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

7. The **Audited Utilization Certificates** towards releases made during the year **2020-21** from the above State have been received.

8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.

9. The expenditure covered by this sanction will be met from the funds provided under Major Head - **3601 - Grants-in-aid to State Governments** (Major Head) **06 - Centrally Sponsored Schemes** (Sub-Major Head); **06.102 - Externally Aided Projects-Grants for Centrally Sponsored Schemes** (Minor Head) **04-National Rural Health Mission**(Sub-head);**04.01-New; 04.01.31-Grants-in-Aid-General Demand No.44-Ministry of Health & Family Welfare** during **2021-2022**.
