- The State/UT shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The **Audited Utilization Certificates** towards releases made during the year 2020-21 from the UT of Puducherry have been received.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
- The expenditure covered by this sanction will be met from the funds provided under Major Head - **3602 - Grants-in-aid to Union Territory Governments with Legislature** (Major Head) **06 - Centrally Sponsored Schemes** (Sub-Major Head); **06.102 - Externally Aided Project - Grants for Centrally Sponsored Schemes** (Minor Head) **01-National Rural Health Mission**(Sub-head); **01.01-Flexible Pool for Communicable Diseases**; **01.01.31-Grants-in-Aid-General Demand No. 44-Ministry of Health & Family Welfare** during **2021-2022**.
