
**Subject: Administrative approval of 1<sup>st</sup> Supplementary PIP- FY 2021-22 for the State of Punjab under NHM - reg.**


2. Approval of the competent authority is conveyed to the State of Punjab for an additional amount of **Rs 0.83 Crores** for FY 2021-22 and the supplementary approvals is summarized as under:

3. With the above approvals, **the total amount approved for FY 2021-22 stands at Rs.1080.42 Crores (including IM and Immunization Kind Grants)**. The approval is accorded to the State subject to the condition that the enhanced approval does not entitle the State to enhance their RE and the State would have to undertake the approved activities within the existing Resource Envelope for FY 2021-22.
4. All the conditionalities outlined under the Main RoP/Administrative Approvals for FY 2021-22 are applicable to Supplementary approvals for FY 2021-22, unless stated otherwise.
