### Vision – Leprosy free India by 2030 Objectives


To reduce Prevalence rate less than 1/10,000 population at District level


Grade II disability % among new cases to Zero, disability cases per million population to Zero at National level

Zero disabilities among new pediatric cases Zero stigma and discrimination

- Leprosy is one of the oldest disease of mankind, it is chronic infectious disease, if not treated timely, leads to deformity and disabilities
- India has achieved leprosy elimination at National Level in Dec 2005 (PR<1/10000 Population)
- India has highest leprosy burden (58% of new cases) in the world
- In year 2019 -20, 114451 new cases were detected while 65164 new cases during 2020-21

### Trends of ANCDR and PR (2001-02 to 2020-21)






TREND OF DISTRICT ENDEMICTY



ANCDR per 1 lac population 23.4 to 4.5 PR per 10000 Population reduce 1.34 to 0.41




#### State/UT wise New Leprosy cases FY 2019-20




#### State/UT wise Grade 2 Disability Cases FY 2019-20




State/UT wise Number of New Leprosy Cases FY 2020-21




State/UT wise Grade 2 Disability absolute number FY 2020-21





Newer Initiatives under NLEP

- Active Case Detection and Regular Surveillance both in rural and urban areas.
- Leprosy screening has been integrated with RBSK and RKSK for screening of children (0-18 years)
- Leprosy screening has been integrated with the activities of CPHC under Ayushman Bharat Yojana for screening of people above 30 years of age.
- Contact tracing is done and Post Exposure Prophylaxis (PEP)
- DPMR i.e. Reaction management, provision of Microcellular Rubber (MCR) footwear, Aids & Appliances, self-care kits etc.
- RCS are conducted at District Hospitals/Medical Colleges/ Central Leprosy Institutes, and welfare allowance @ Rs 8000 is paid to each patients undergoing RCS.
- Guidelines for certification and award at District Level for achieving potential leprosy elimination under NLEP. i, e Silver Category & Gold Category – Cash prize, Certification, Felicitation at National level
