

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 3316000.00 (Rupees Thirty Three Lakh Sixteen Thousand Only)** to the State/UT of **PUNJAB** towards liquidation of **Arrears for the F.Y. 2020-21** for implementation of Infrastructure Maintenance - **Urban Family Welfare Centres (UFWCs)**, a Centrally Sponsored Plan Scheme during **2022-2023**. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
