3. The placement of funds is subject to the:-



d). The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department **CHANDIGARH** as per approved action plan 2022-23 as entrusted by the Ministry of Health and Family Welfare.


e). Expenditure other than the item No. (d) can be incurred out of the above allocation only after the approval of Ministry of Health and Family Welfare.


