1. I am directed to convey the sanction of the President of India for distribution of the Supplies & Material to various State and UT Governments, worth **Rs. 74,92,334/- (Rupees Seventy Four lakh Ninety Two thousand Three hundred Thirty Four only)** procured by Govt. of India from their own funds in connection with the intensification of NCVBDC (RURAL) and supplied to the State and UT Govts. during the years 2018-19, 2019-20 and 2020-21.
