CORRIGENDUM

Subject: Amended Minutes of the 8th Empowered Programme Committee (EPC) of National Health Mission (NHM) held on 19.12.2019

Kindly refer to this Ministry's OM of even number dated the 9th January 2020 on the subject cited above.

2. The EPC decision for Agenda 6 (a) is amended as below:

“It was decided to recommend to MSG to extend the benefit of free referral transport under JSSK, currently available to pregnant women for institutional delivery including antenatal & post - natal complications of pregnancy and sick infants up-to one year of age accessing public health institutions, to SAM children aged 1-5 years for admission in NRCs and follow up visits to NRCs after discharge as well.”

In place of “It was decided to recommend to MSG to approve transport cost per child for referral and follow up visits as proposed only for such areas where 102 ambulances are not there as per existing norms.”

3. The EPC decision for Agenda 13 is amended as below:

“The proposal for provision for increase in duration of the training from 16 to 24 weeks for EMOC and from 18 to 24 weeks for LSAS is recommended by EPC for consideration and approval by MSG. This should be done for two years first and then evaluated.”

In place of “the proposal for provision for increase in duration of the training from 16 to 24 weeks for EmOC and from 18 to 24 weeks for LSAS was approved. It was also approved to support the training cost of CEmONC and LSAS within the resource envelope of the States/UTs. This should be done for six months first and then evaluated.”

The amended minutes are issued with the approval of Chairperson of EPC, Secretary, MOHFW.
