

Centres; 05.07.31- Grants-in-aid-General in Demand No.42– Health & Family Welfare during 2018-19. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.


