I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.23,10,62,000/-** (Rupees Twenty three crore ten lakh and sixty two thousand only) to the State of **Chhattisgarh** towards liquidation of Arrears of 2016-17 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2018-19. With this release, the arrears will be settled up to 2016-17.

This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
