The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601-Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 796 – Tribal Area Sub Plan (Minor Head); 05 - FW-Infrastructure Maintenance; 05.02- Sub-Centres; 05.02.31- Grants-in-aid-General in Demand No.42– Health & Family Welfare during 2018-19. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3481 dated 25.02. 2019.


