

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.7,59,000/- (Rupees Seven lakh and fifty nine thousand only only)** to the State of **Telangana** towards liquidation of Arrears of 2014-15 and 2015-16 for implementation of Infrastructure Maintenance (**Sub-Centres**), a Centrally Sponsored Plan Scheme during 2018-19. With this release, the arrears will be fully settled up to 2014-15 and partially settled up to 2015-16.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601-Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 796 – Tribal Area Sub Plan (Minor Head); 05 - FW-Infrastructure Maintenance; 05.03- Urban Family Welfare Centres (UFWCs); 05.03.31- Grants-in-aid-General in Demand No.42- Health & Family Welfare during 2018-19. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3551 dated 26.02.2019.
