
I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.6,31,70,000/- (Rupees Six crore thirty one lakh and seventy thousand only)** to the State of **Telangana** towards liquidation of Arrears of 2014-15 and 2015-16 for implementation of Infrastructure Maintenance (Training of ANM/LHVs), a Centrally Sponsored Plan Scheme during 2018-19. With this release, the arrears will be fully settled up to 2014-15 and partially settled up to 2015-16.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Government (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2018-19. This amount is for salary of regular staff of State Government as per Ministry of Health and Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.


