Subject: Release of Grants-in-aid to the UT of Delhi for **Flexible Pool for Communicable Diseases.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.6,51,00,000/-** (Rupees Six Crore and Fifty One Lakh Only) **to the UT of Delhi** towards first Installment of Grants-in-Aid for Revised National TB Control Programme, one of the National Diseases Control Programmes under Flexible Pool for Communicable Diseases for the year 2018-19.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in cash.
3. The UT of Delhi shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The UT of Delhi shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
5. The UT of Delhi shall ensure that 40% of its share based on release of funds by GOI is credited to appropriate accounts.
6. Grant in-Aid shall be used for the purpose for which the sanction is given. A annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The Audited Utilization Certificates towards releases made during the year 2017-18 have been received from UT of Delhi.
8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
9. The Expenditure covered by this sanction will be met from the funds provided under Demand No.42 - 3602-Grants in Aid to Union Territory Governments with Legislature-(Major Head), 06-Centrally Sponsored Scheme (Sub-Major Head), 06.102-Externally Aided Projects-Grants for Centrally sponsored Schemes (Minor Head), 01-National Rural Health Mission, 0101-Flexible Pool for Communicable Diseases, 010131-Grants in Aid-General for the year 2018-19.
