2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in cash.
3. The UTs shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The UTs shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
5. The UTs shall ensure that 40% of its share based on release of funds by GOI is credited to appropriate accounts..
6. Grant in-Aid shall be used for the purpose for which the sanction is given. A annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The Audited Utilization Certificates towards releases made during the year 2017-18 from the UT have been received.
