

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.25,11,36,000/-** (Rupees Twenty five crore eleven lakh and thirty six thousand only) to the State of **Andhra Pradesh** towards liquidation of Arrears of 2016-17 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be settled up to 2016-17.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06789 – Special Component Plan for Scheduled Castes (Minor Head); 05 - FW-Infrastructure Maintenance (Sub-Head); 05.02-Sub-Centres; 05.02.31- Grants-in-aid – General in Demand No.42– Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. This sanction issues with the concurrence of Integrate Finance Division vide Dy. No. C-236 dated 26.04.2019.


