I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.7,95,00,000/- (Rupees Seven crore and ninety five lakh only)** to the State of **Telangana** towards liquidation of Arrears from 2015-16 to 2017-18 for implementation of Infrastructure Maintenance (Training of ANM/LHVs), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be fully settled up to 2016-17 and partially settled up to 2017-18.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Government (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
