Subject: Release of Grants-in-Aid Funds towards Incentives for Flexible Pool for Non-Communicable Diseases - **SCSP (Scheduled Castes Sub Plan)** for the year 2019-20 – **Sanction Reg..**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.2,71,00,000/- (Rupees Two Crore and Seventy One Lakh Only)** to the State of Uttar Pradesh as Grants in Aid towards First Tranche of Incentive for the year 2019-20 for implementation of various Diseases Control Programmes under the **Flexible Pool of Non-Communicable Diseases** :

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The State shall ensure that 40% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The Provisional Utilization Certificates towards releases made during the year 2018-19 from the above States have been received.
8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
9. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 - Centrally Sponsored Schemes (Sub-Major Head); 789 - Scheduled Castes Sub Plan (Minor Head); 04- Flexible Pool for Non-Communicable Diseases (Sub-Head); 04.04- Flexible Pool for Non-Communicable Diseases (New); .04.04.31- Grants in Aid General under Demand No.42 – Health & Family Welfare during 2019-20




