Subject: Release of Second Installment of Grants-in-Aid for **NVHCP Programme** under Flexible Pool for Communicable Diseases for the year 2019-20 – **Sanction Reg.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.9,00,000/- (Rupees Nine Lakh Only)** to the **UTs of Delhi and Puducherry** towards Second Installment of Grants-in-Aid up to 100% of Budget Allocation for the financial year 2019-20 for implementation of National Viral Hepatitis Control Program (**NVHCP**), one of National Diseases Control Programmes (NDCPs) under the **Flexible Pool of Communicable Diseases** during 2019-20.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The UTs shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The UTs shall ensure that 40% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The UTs shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. Since NVHCP programme launched recently under the Flexible Pool of Communicable Disease, the conditions of submission of Provisional Utilization Certificates for the financial year 2018-19 is not applicable.
8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.


