

This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3166 dated 17.12.2019.


