Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.3,00,000/- (Rupees Three Lakh Only)** to the **State of Sikkim** towards Second Installment of Grants-in-Aid up to 100% of Budget Allocation for 2019-20 for implementation of **NVHCP Programme**, one of National Diseases Control Programmes (NDCPs) under the **Flexible Pool of Communicable Diseases** during 2019-20.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid through e-payment to the **State Government of Sikkim**. 3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The State shall ensure that 10% of its share based on release of funds by GOI is credited to appropriate accounts.

5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

6. Grants in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

7. The NVHCP programme has been launched recently hence Audited Utilization Certificates are not due under this programme.


8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
