The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The Provisional Utilization Certificates towards releases made during the year 2018-19 from the above States have been received.
8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
9. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-Aid to State Governments (Major Head); 06–Centrally Sponsored Schemes (Sub-Major Head); 101 – Central Assistance/Share (Minor Head); 13- National Rural Health Mission; 13.03- Flexible Pool for Communicable Diseases; 13.03.31- Grants in Aid General under Demand No.42 – Health & Family Welfare during 2019-20.
10. The Grants-in-Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
11. This sanction issues with the concurrence of Integrated Finance Division vide their **Diary No. C-3168 dated 17.12.2019**.
