I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.48,80,43,000/- (Rupees Forty eight crore eighty lakh and forty three thousand only)** to the State of **Assam** towards liquidation of Arrears of 2018-19 for implementation of Infrastructure Maintenance (**Sub-Centres**), a Centrally Sponsored Plan Scheme during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-4214 dated 09.03.2020.
