
Subject: Family Welfare Programme - Release of first, second, third and fourth instalment of grants-in-aid for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during 2019-20 – Urban Family Welfare Centres – General.

Sir,

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.87,92,000/- (Rupees Eighty seven lakh and ninety two thousand only)** to the State of Jharkhand towards the first, second, third and fourth instalments for implementation of Infrastructure Maintenance (Urban Family Welfare Centres), a Centrally Sponsored Plan Scheme during 2019-20.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101- Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.03-Urban Family Welfare Centres (UFWCs); 14.03.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2019-20 . This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form GFR 12C) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
5. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
6. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
7. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3839 dated 03.02.2020.


