

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.79,25,94,000/- (Rupees Seventy nine crore twenty five lakh and ninety four thousand only)** to the State of **Karnataka** towards the liquidation of Arrears of 2017-18 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be settled up to 2017-18.

This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-4142 dated 28.02.2020.
