

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.11,32,28,000/- (Rupees Eleven crore thirty two lakh and twenty eight thousand only)** to the State of **Karnataka** towards liquidation of Arrears of 2017-18 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be settled up to 2017-18.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.

This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
