FW Bureaux; 14.01.31- Grants-in-aid – General in Demand No.42-Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.



7. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3510 dated 15.01.2020.


