I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.45,67,95,000/- (Rupees Forty five crore sixty seven lakh and ninety five thousand only)** to the State of **Odisha** towards the liquidation of Arrears of 2017-18 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be partially settled up to 2017-18.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance (Sub Head); 14.02-Sub-Centres; 14.02.31- Grants-in-aid General in Demand No.42- Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3982 dated 24.02.2020.
