I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.13,66,51,000/- (Rupees Thirteen crore sixty six lakh and fifty one thousand only)** to the State of **Odisha** towards liquidation of Arrears of 2017-18 for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2019-20. This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
