
Subject: Family Welfare Programme - Release of Grants-in-aid during 2019-20 for liquidation of Arrears of 2017-18 and 2018-19 for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme – **Urban Family Welfare Centres – General.**

Sir,

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.5,41,000/- (Rupees Five lakh and forty one thousand only)** to the State of **Tripura** towards liquidation of Arrears of 2017-18 and 2018-19 for implementation of Infrastructure Maintenance (Urban Family Welfare Centres), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be fully settled up to 2017-18 and partially settled up to 2018-19.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.03-Urban Family Welfare Centres (UFWCs); 14.03.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
5. This sanction issues with the concurrence of Integrate Finance Division vide Dy. No. C-4222 dated 09.03.2020.
