

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Government (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.

5. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-4222 dated 09.03.2020.
