

3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The States shall ensure that 40%/10% (as applicable) of its share based on release of funds by GOI is credited to appropriate accounts.


5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 - Centrally Sponsored Schemes (Sub-Major Head); 789 - Scheduled Castes Sub Plan (Minor Head); 04- Flexible Pool for Non-Communicable Diseases (Sub-Head); 04.04- Flexible Pool for Non-Communicable Diseases (New); .04.04.31- Grants in Aid General under Demand No.42 – Health & Family Welfare during 2019-20
10. The Grants-in-Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
11. This sanction issues with the concurrence of Integrated Finance Division vide their **Diary No. C-4146 dated 29.02.2020.**


