

Subject: **Release of Grants-in-aid under RCH Flexible Pool including (Excluding RI, PPI and NIDDCP) - SCSP (Scheduled Castes Sub Plan).**

Sir,

I am directed to convey the sanction of the President of India to the payment of **Rs.33,00,000/- (Rupees Thirty Three lakh Only)** to the State of **West Bengal** towards grants-in-aid under RCH Flexible Pool (Excluding RI, PPI and NIDDCP) during the FY 2019-20.


2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The States shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. Audited Utilization Certificate for the FY 2018-19 has been received.
6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
8. The expenditure involved is recurring and will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 789 – Special Component Plan for Scheduled Castes (Minor Head); 04- National Rural Health Mission 04.01- RCH Flexible Pool including RI, PPI, NIDDCP; 04.01.31- Grants-in-aid – General in Demand No.42 – Health & Family Welfare during 2019-20.

10. This sanction issues with the concurrence of Integrated Finance Division vide Dy. No. C-3699 dated 03.02.2020


