I am directed to convey the sanction of the President of India for release of an amount of Rs.12,61,00,000/- (Rupees Twelve crore sixty one lakh only) to the following two States as first Installment of Grants-in Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme for the year 2015-16 as lump sum for undertaking various activities for implementation of RNTCP in the State.

- The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan Finance Division) Vide their O.M. No.10(I)-PF-1/76 dated 22th January, 1977 and is to be paid in cash.
- The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, Gol.
- The State shall ensure that 40% of its share based on release of funds by Gol is credited to appropriate accounts.
- The state shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMR/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
- The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

7 The Expenditure covered by this sanction will be met from the funds provided under Demand No.48 – 3601 –Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02263 –Public Health-Prevention and Control of Diseases (Minor Head), 08- Flexible Pool for Communicable Diseases GC, 080031 –Grants in Aid General (Plan) for the year 2015-16.
