- The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, Gol.
- The State shall ensure that 10% of its share based on release of funds by Gol is credited to appropriate accounts.
- The state shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMR/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
- The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.



7.. The Expenditure covered under the sanctioned budget Head (Plan) Demand No.48 – 3601 –Grants in Aid to state Government (major Head), 02263- Public Health-Prevention and control of Diseases (Minor Head), 08-Flexible Pool for communicable Diseases, 080031-Grants in Aid General for the year 2015-16.

8. The Grants –in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
