Subject: Consent for making VHSNC as a sub-committee of Gram Panchayats.

Please refer to the subject noted above.

The Govt. of India, Ministry of Health & Family Welfare, Nirman Bhawan, New Delhi have decided that the role of the Village Health & Sanitation Committees(VHSCs) may be expanded so as to include 'Nutrition' within its ambit with the active participation of Anganwadi Workers, ANMs and ASHAs. The committees will be named as Village Health, Sanitation & Nutrition Committees (VHSNCs). It has further been decided by the Govt. of India that these committees may, preferably, act as a sub-committee of Gram Panchayat & function under the overall supervision of Gram Panchayats. The Govt. of India has accordingly advised to issue necessary notification in this regard. The NRHM, U.T., Chandigarh has already constituted the Village Health and Sanitation Committees(VHSCs) and now with the decision of GOI, it is to be re-constituted by adding the component of 'Nutrition' in these committees. Hence, before it is done and the committees are made as a sub-committee of Gram Panchayats your consent is required as the Gram Panchayats are functioning under the control and supervision of your department. You are accordingly requested to convey your consent in this regard immediately.
