Dear Mission Director,

Government of India launched the scheme of 'Home delivery of contraceptives' (HDC) by ASHAs in 2011. The scheme has helped in improving contraceptive access in the community.

Under the existing HDC scheme, the 'Free supply' component was withdrawn from the sub block level facilities viz. PHCs and SCs, and ASHAs were entrusted to cater to this section of the beneficiaries at their homes with nominally costed commodities. 'Free supply' component, however, continued to be available at higher level facilities viz. CHCs, SDHs and DHs.

Evaluation of the scheme has revealed that due to non-availability of the contraceptives at PHCs and SCs, the beneficiaries who approach the facilities directly are not able to get the commodities. Also some male beneficiaries find it difficult to approach ASHAs for their need of condoms due to existing socio cultural barriers.

To address these challenges and further improve contraceptive access, Government has devised the *Modified Scheme for Home delivery of contraceptives* under which the free supply has been restored at the PHC and SCs to cater to the beneficiaries who want to access the facilities directly. Further, the states also need to ensure the availability of condom boxes in all facilities so that clients can freely access the condoms.

Annexure A

Modified Scheme for Home Delivery of Contraceptives: (and Placement of Condom Boxes in Health facilities)

Coverage: The modified scheme will be applicable uniformly all across the country.

Date of initiation of the modified scheme: From the date of issue of this letter.

Key Highlights:

- States to restore the 'free supply' to all the facilities viz. PHCs, SCs.
- The revised apportioning of commodity will be 70% for 'ASHA' and 30% for 'Free supply' as against the existing 90% and 10%.
- However, the states are allowed the flexibility to apportion the supply judiciously to the 'free supply' and 'ASHA supply' components as per their consumption pattern.
- The programme to be monitored through a simplified reporting system to enhance the compliance at the field level.

• Installing Condom Boxes:

- o Installing Condom Boxes at convenient locations away from public glare to maintain privacy. (Number of condom boxes may vary based on the level and type of the facilities, demand and eligible couples catered to by the facilities).
- o The boxes may be made from available resources and appropriately displayed.
- Each condom box in a facility to be mandatorily tagged and should be given a unique number (For eg: Condom Box-1; Condom Box-2 etc.) if it is more than one.
- O Condom boxes may be replenished monthly or sooner based on the consumption pattern.
- o It should be replenished by the 'free supply' component.

Monitoring Mechanism:

Each facility to maintain a separate register for recording consumption and replenishment of the condom boxes.
